- Asian equities are higher following the rally on Wall St the Nikkei is at +2.08%, the Shanghai composite is at -0.0%, the Hang S at -0.38%, and the ASX is at +1.49%.
- The US dollar corrected lower the DXY index is at 109.76 the EUR is at 0.9987, USD/JPY is at 144.1. while the AUD is at 0.6728.
- US treasury yields are sharply lower, erasing the previous days gains the 2 year yield is at 3.435% while the 10 year yield sits a 3.241.
- Gold opened around the NY highs and has drifted only slightly lower through Asian hours, the yellow metal is sitting at \$1715 a write.
- Silver mounted an impressive rally overnight and is currently trading at \$18.44.
- Gold ETFs sold 42koz overnight to a gross total of 99.50 million ounces.
